Many of these letters are offered by family members and all of them are composed by Jehovah's Witnesses. If you notice the way they are written they seem to follow a pattern in how they are composed. Do you think the home office of Jehovah's Witnesses gave them coaching tips on what to say? That will remain to be seen. Also note the references to Brother Beliz preaching activity, going door to door, as being evidence of how well he was doing. Once again, a few chose to mention that they wanted this twice convicted child molester to baby sit their children. The truth is truly stranger than fiction.
